



BULLETIN OF BASIC PROSECUTION OFFICE - GJILAN

April - June 2024



This bulletin reflects the main activities, which have been carried out at the Basic Prosecution Office in Gjilan, for the period April - June 2024.

Chief Prosecutor Kadriu hosted the Central Labor Inspectorate for the Gjilan region

Gjilan, April 16, 2024

Chief Prosecutor of the Basic Prosecution in Gjilan, Mr. Arben Kadriu hosted the leader of the Central Labor Inspectorate for the region of Gjilan, Ms. Muhabere Konesha and the labor inspector Mr. Bujar Xhelili.

The prosecutor from the General Department of this prosecution, Mrs. Rozelida Manastiri was present at the meeting.

During this meeting, the main topic of discussion was safety and health at work, where special importance was given to the construction sector in order to take preventive measures regarding the work process, in order to avoid and minimize risks, which are caused by the exercise of work activity.

The Chief Prosecutor informed the attendees that the Basic Prosecution Office in Gjilan has handled many cases regarding accidents at work or due to work and that in many cases indictments have been filed.

At the end of the meeting, the attendees agreed to continue taking preventive measures, which aim to improve working conditions, improve the working environment and protect the health of workers.



Chief Prosecutor Kadriu hosted the Kosovo Police for the Gjilan region in a meeting

Gjilan, April 19, 2024

Chief Prosecutor of the Basic Prosecution in Gjilan, Mr. Arben Kadriu, received in a working meeting the Director of the Regional Police of Gjilan, Mr. Agron Rukiqi, commanders of Police Stations for the region of Gjilan, Heads of regional investigations, as well as the representative of the victims' defense.

The coordinating prosecutor for domestic violence, Mrs. Leonora Kadriu and prosecutors from the Serious Crimes Department took part in this meeting.

During this meeting, it was discussed about the establishment of cooperation between the Basic Prosecution Office in Gjilan and the Police, about the problems and difficulties they face during the exercise of their duties.

Among other things, the coordination and undertaking of actions regarding the fight against criminality in general was discussed, with a special focus on the treatment of cases of domestic violence, with the aim of preventing and providing the safety of victims, raising responsibility, and assessing the risk, with the aim of taking urgent measures from the initial stage of presenting cases.

At the end of the meeting, both institutions appraised the cooperation so far and expressed readiness for further cooperation.





JOINT PRESS RELEASES FROM THE BASIC PROSECUTION OFFICE IN GJILAN AND THE KOSOVO POLICE - REGIONAL DIRECTORATE IN GJILAN

Gjilan, May 30, 2024

The Basic Prosecution Office in Gjilan, informs the public that in full coordination with the Kosovo Police - Regional Directorate in Gjilan, after intensive investigations, detained the suspect N.R., due to the criminal offense of “False notification or report”. under the Criminal Code of the Republic of Kosovo.

The aforementioned suspect on May 25, 2024, around 00:56, reported that while she was walking to the city cemetery in Gjilan with her son, she was stopped by two masked persons, who threatened they had pulled her inside the fence of the cemetery, where then, according to her, they sexually assaulted her and forcibly robbed her of her gold jewelry.

The Basic Prosecution Office in Gjilan, in full coordination with the Regional Investigations Unit in Gjilan, in order to clarify this case, have undertaken intensive investigative actions, based on the evidence obtained, the statements of the parties involved in the case, the medical reports from the Institute of Forensic Medicine, after analyzing many materials with video-recordings, evidence was provided that the whole event was staged and the same was falsely reported when reporting it to the police.

By order of the prosecutor, the suspect is detained for 48 hours, and within the legal deadline, a decision will be made regarding the measures to ensure her presence in the criminal procedure.


Indictment for Fraud

Gjilan, June 12, 2024

The Basic Prosecution in Gjilan, General Department, has filed an indictment against the defendant D.A. for the criminal offense of “Fraud” under Article 323, paragraph 1, in connection with Article 77 of the Criminal Code of the Republic of Kosovo.

According to the indictment, there is well-founded suspicion that the defendant D.A., from December 24, 2023, to March 28, 2024, continuously, in his business named “Albshkolla” in Gjilan, misled the victims I.K., L.H., V.M., F.O., J.S., Y.B., A.V., M.A., R.A., N.S., A.R. by presenting false facts and with the intention of unlawfully gaining property. He deceived the victims, causing them to act to their detriment by opening a fake online school called “Albshkolla,” employing the victims as teachers and other staff positions. He signed fixed-term contracts with them, promising salaries ranging from 400 to 1,000 euros. The victims, falling prey to the fraud, began working and providing services in their respective roles, but the defendant did not pay them for their services.

Additionally, in February 2024, the defendant received a gold plaque from the victim Y.B., claiming to repair it, which he never returned. Through his fake platform, he also induced other individuals to pay 12 euros into his “Albshkolla” account for online services that were never provided.



For these actions, the defendant D.A. has committed the aforementioned criminal offense, and upon the prosecution's request, is currently under detention on remand.

Basic Prosecution in Gjilan resolves 32 cases through mediation in the second quarter of 2024

April - June 2024

The Basic Prosecution in Gjilan, in the second quarter of 2024, specifically in the period from April to June 2024, referred a total of fifty-three (53) cases involving sixty-five (65) individuals for resolution through mediation for criminal offenses punishable by a fine or imprisonment of up to three (3) years, or both.

Through this procedure, thirty-two (32) cases involving thirty-nine (39) individuals were resolved, including offenses such as “Threat,” “Assault,” “Light Bodily Injury,” “Abuse of Trust,” “Theft of Services,” “Destruction or Damage of Property,” and “Vigilantism,” as per the Criminal Code of the Republic of Kosovo.

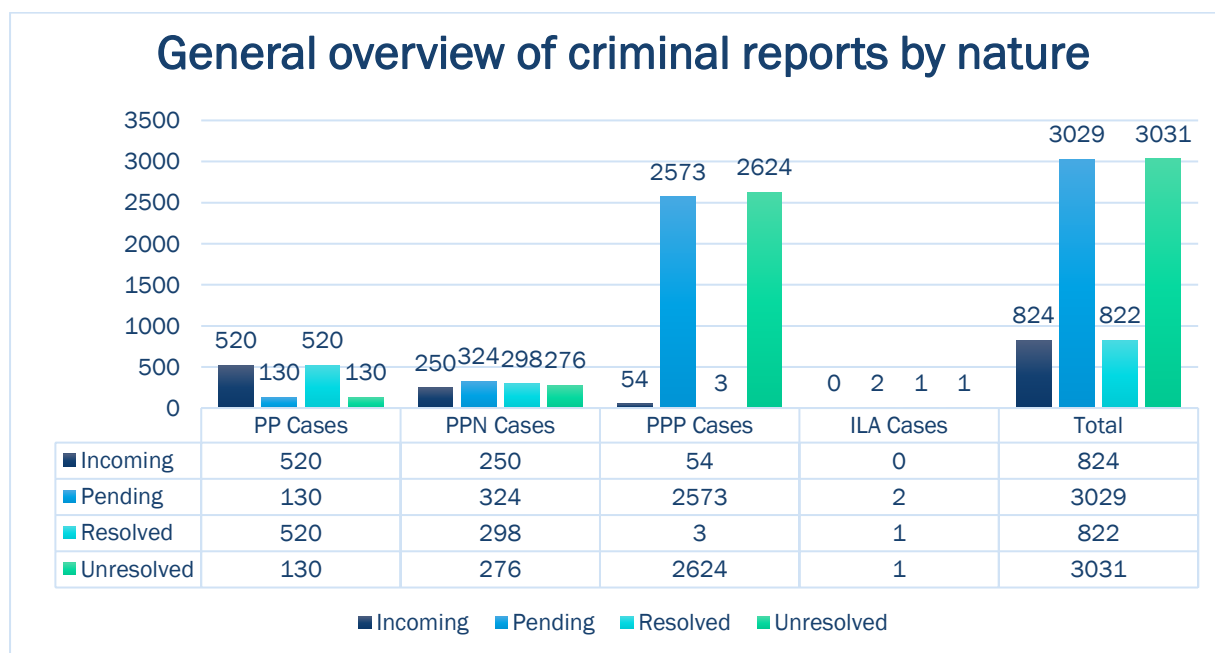
During this period, despite the referral of cases, twenty (20) cases involving twenty-two (22) individuals were not resolved through mediation due to a lack of agreement between the defendants and the victims, and one (1) case involving three (3) individuals is still in process.

General Statistical Data by Type of Criminal Report

April - June 2024

The Basic Prosecution in Gjilan received a total of 824 cases (from registers PP, PPN, PPP, and ILA) and resolved 822 cases, achieving an overall case handling efficiency rate of 99.75% of transferred cases.
