

# BULLETIN OF BASIC PROSECUTION IN MITROVICA



This bulletin reflects main activities, which have been carried out at the Basic Prosecution in Mitrovica, for the period July – September 2024

## Two people suspected of fraud and illegal exercise of medical or pharmaceutical activity were arrested in Vushtrri

#### Mitrovica, July 16, 2024

The Basic Prosecution Office in Mitrovica informs the public that two individuals, with the initials N.M. and P.I., have been arrested in Vushtrri on suspicion of committing the criminal offenses "Illegal exercise of medical or pharmaceutical activity" under Article 256 of the Criminal Code of the Republic of Kosovo (KPRK) and "Fraud" under Article 323 of the same code.

The suspects, by decision of the prosecutor, are detained for 48 hours. Today, July 16, the Basic Prosecution Office in Mitrovica will submit a request to the Basic Court - Vushtrri Branch to impose a security measure - a detention measure against the suspects.

## **Call for Cooperation**

### Mitrovica, July 18, 2024

The Basic Prosecution Office in Mitrovica appeals to all individuals who have received "medical" treatment from the persons with the initials N.M. and P.I., who operated under the Bio Mulaku business in Vushtrri, and who are suspected of the criminal offenses "Fraud" and "Illegal exercise of medical or pharmaceutical activity," to report to the nearest police station of their place of residence to provide a statement in the capacity of a victim/witness.

The Basic Prosecution Office in Mitrovica, in full coordination with the Kosovo Police, is continuing to handle this case.

## A person arrested for threatening journalists of the portal "Mitropol"

### Mitrovica, 26 July 2024

The Basic Prosecution in Mitrovica informs the public that a suspect with the initials F.A., from Vushtrri, has been arrested on suspicion of threatening journalists of the portal "Mitropol" from Mitrovica. The threat is believed to be related to an article published by the portal about the installation of a small amusement park in the main square of Vushtrri.

Through these actions, the suspect is alleged to have committed the criminal offense of "Threat" under Article 181 of the Criminal Code of the Republic of Kosovo.

The suspect is currently being held in 48-hour detention as per the prosecutor's decision.



## Chief Prosecutor of the Basic Prosecution Office in Mitrovica, Ismet Ujkani, Retires



#### Mitrovica, August 2, 2024

The Basic Prosecution Office in Mitrovica announces to the public that the Chief Prosecutor of this office, Ismet Ujkani, has reached the age of retirement.

Chief Prosecutor Ujkani has served as the Chief Prosecutor at the Basic Prosecution Office in Mitrovica since January 1, 2021.

Previously, Mr. Ujkani held the position of prosecutor in the Serious Crimes Department of this Prosecution Office, prosecutor at the District Prosecution Office in Mitrovica, and prosecutor at the Municipal Prosecution Office in Mitrovica.

Mr. Ujkani has made a valuable contribution to the prosecutorial system of the Republic of Kosovo with his dedication and professionalism.

## The Basic Prosecution Office of Mitrovica has filed forty-eight (48) indictments against seventy-two (72) individuals over the course of five working day



### Mitrovica, August 5, 2024

Over the course of five working days, from July 29 to August 2, 2024, the engagement of prosecutors from the Basic Prosecution Office in Mitrovica resulted in the filing of forty-eight (48) indictments against seventy-two (72) individuals for various criminal offenses.

The indictments filed by prosecutors from the Basic Prosecution Office in Mitrovica are for the following criminal offenses: "Robbery", "Fraud", "Assault", "Threat", "Unauthorized Purchase, Possession, Distribution, and Sale of Narcotics, Psychotropic Substances, and Analogues", "Domestic Violence", "Unauthorized Crossing of Border Crossings or the Border Line", "Endangerment of Public Traffic", "Destruction or Damage to Property", "Theft of Services", "Theft", "Smuggling of Goods", "Forgery of Documents", "Violation of Social Security Rights", "Receiving a Bribe", "Misappropriation of Another's Property", "Contempt of Court", "Minor Bodily Injury", "Unauthorized Ownership, Control, or Possession of Weapons", "False Representation as an Official Person", and "Theft of Forest".

At the same time, we appeal to all citizens who have received such requests and to those who have shared their bank account information and may have potentially suffered damages, to report to the nearest police station in your area of residence to provide a statement as a victim/witness.

The Basic Prosecution in Mitrovica informs the public that Zejnije Kela, a prosecutor in the Juvenile Department, has reached the retirement age.

Previously, Prosecutor Kela served as a prosecutor at the Municipal Prosecution in Mitrovica, Deputy/Chief Prosecutor at the Municipal Prosecution in Mitrovica, and as a prosecutor at the District Prosecution in Mitrovica.

## Acting Chief Prosecutor Njazi Rexha Continues Open Meetings with Citizens

#### Mitrovica, August 22, 2024

Njazi Rexha, the Acting Chief Prosecutor of the Basic Prosecution in Mitrovica, has scheduled Thursdays <u>from 13:15 to 15:00</u> as part of his weekly agenda for meetings with citizens.

In recent weeks, the demand for meetings with Acting Chief Prosecutor Rexha has been quite high. Citizens have expressed their gratitude for the opportunity and the transparency demonstrated by the head of the Basic Prosecution in Mitrovica. Mr. Rexha has, in turn, expressed his willingness and the support of the institution he leads to address citizens' requests, providing them with the necessary clarifications.

## Weekly Work Report of the Basic Prosecution in Mitrovica

#### Mitrovica, 26 August 2024

During the week of 19–25 August 2024, the Basic Prosecution in Mitrovica received a total of fifty-three (53) criminal reports involving sixty-six (66) individuals.

In the same period, sixty-one (61) indictments were filed against seventynine (79) persons.

Additionally, five (5) individuals were detained in separate cases, and five (5) motions for detention on remand were submitted for five (5) individuals.

Moreover, ten (10) cases involving twelve (12) individuals were resolved through alternative mediation procedures.

## Indictment against Individual for Threatening the Owner of Veriu.info

#### Mitrovica, September 2, 2024

The Basic Prosecution Office in Mitrovica announces that an indictment has been filed against an individual with the initials L.L., based on wellfounded suspicion of committing the criminal offense of "Threat," under Article 181, Paragraph 1 of the Criminal Code of the Republic of Kosovo.

On August 28, around 10:00 PM in Mitrovica, the accused L.L. seriously threatened G.M., the owner of the Veriu.info portal, by threatening to cause harm due to the publication made by the portal regarding the arrest of L.L.'s father. The accused sent threatening messages, causing the victim emotional distress and fear.

With these actions, the accused has committed the criminal offense as charged. The State Prosecutor has proposed to the court that the accused be found guilty of the criminal offense and be sentenced according to the law.
